# **Chapter 1 Admission policy**

#### Section 1.1 Mission and educational philosophy

Hiroshima Global Academy (HiGA) opened in April 2019, with the mission of fostering leaders who create a "better future" for peace and sustainable development, with the aim to be a global leader in building peace with the power of "learning".

In line with this mission, HiGA aims to develop students who have the following five competencies.

- 1. Deep understanding to apply knowledge and skills to new challenges
- 2. Creative and critical thinking skills to create new values
- 3. Collaboration skills to cooperate with people from different cultures that have different values
- 4. Confidence to see things through to accomplish targets
- 5. Communication skills to discuss and cooperate with people in Japanese and English

The school's curriculum is based on the development of these competencies and is linked to the International Baccalaureate Middle Years Programme and the Diploma Programme (DP), all of which are linked to the research carried out by universities.

#### Section 1.2 Ideal candidate profile for HiGA

The school welcomes students from all over Japan and the world who share this educational philosophy and who have a strong desire to learn. We are looking for students who are ready for the DP, who can understand things conceptually, who have the language skills to understand classes conducted in English, and who have a strong desire to think creatively and critically in an inquiry-based learning environment. Most importantly, they will have an interest in learning and a commitment to personal growth through living with people from different cultures that have different values. The school welcomes students who aspire to become global leaders for the creation of a peaceful and sustainable future.

#### Section 1.3 Basic admission policy

The selection of students for the 2022 academic year at Hiroshima Global Academy will be based on the "Basic Policy on the Selection of Students for the 2022 Academic Year of Hiroshima Prefectural Integrated Junior and Senior High Schools." and the "Admission Guideline of Hiroshima Prefectural Senior High School within Hiroshima's integrated school system (Hiroshima Global Academy) for 2022 Academic Year". Additionally, admissions will be based on the applicant's motivation and aptitude.

# **Chapter 2 Recruitment**

#### Section 2.1 Eligibility for application

Applicants must meet one of the following conditions (a) or (b).

- (a) Those who have foreign citizenship, who were born between April 2, 2005 and December 31, 2007, and fall into one of the following categories by August 2022 are eligible to apply.
  - □ Have graduated or are expected to graduate from junior high school.
  - Fall under or are expected to fall under any of the items outlined in Article
     95 of the Enforcement Regulations of the School Education Law.

#### Enforcement Regulations of the School Education Law (excerpt)

May 23, 1947

Ordinance of the Ministry of Education, Culture, Sports, Science and Technology No. 11

(Persons who are recognized as having academic abilities equivalent or superior to those who have graduated junior high schools)

#### Article 95

Pursuant to Article 57 of the School Education Law, a person who is deemed to have the academic ability equivalent or superior to that of a person who has graduated from a junior high school, regarding admission to a senior high school, must meet one or more of the following conditions:

- 1. Have completed nine years of school education in a foreign country
- 2. Have completed a course, accredited by the Minister of Education, Culture, Sports, Science and Technology as having a course equivalent to a junior high school course, at an overseas educational institution.
- 3. Have been designated by the Minister of Education, Culture, Sports, Science and Technology.
- 4. Have been certified as having academic ability equivalent or superior to that of a junior high school graduate in accordance with the Regulations for Recognition of Junior High School Graduation Levels for Persons Exempted from Deferment of Schooling Obligations (Ministry of Education Ordinance No. 36 of 1966).
- 5. Others who are recognized by the high school as having academic abilities equivalent to or higher than those of a junior high school graduate.

- (b) Those who have Japanese nationality, were born between April 2, 2005 and April 1, 2007, fall under one of the following categories by August 2022, and in principle have studied at an overseas school for at least five years are eligible to apply.
  - □ Have graduated or are expected to graduate from junior high school.
  - Fall under or are expected to fall under any of the items outlined in Article
     95 of the Enforcement Regulations of the School Education Law.

If you want to confirm your eligibility before registering your application, please contact HiGA by July 30 (Fri.), 2021, indicating (1) your name, (2) date of birth, (3) nationality (if you have more than one nationality, indicate both), and (4) length of study at an overseas school (if you are a Japanese citizen).


Please note that the application fee is non-refundable, even if the applicant is judged to be ineligible to apply after payment of the application fee.

# Section 2.2 Application capacity

In principle, the maximum capacity of students per grade level is 30 male and 30 female students. The maximum capacity admitted for this selection method (General selection for foreign and Japanese students) will depend on the number of students who are admitted from HiGA's junior high school and the Selection of students based on overseas collaboration agreement.

#### **Chapter 4 Application**

The forms used in this guideline are the same as those used in the document "Admission Guideline of Hiroshima Prefectural Senior High School within Hiroshima's integrated school system (Hiroshima Global Academy) system for 2022 Academic Year" (published by Hiroshima Prefectural Board of Education).

#### **Section 4.1 Application period**

# 4.1.1 Registration for application

Between August 1 (Sun.), 2021 and August 31 (Tue.), 2021.

# 4.1.2 Submission of the application documents

Please follow the instructions in the email sent by HiGA to the applicant and the principal of the applicant's junior high school. Submit the application documents between August 18 (Wed.) and September 14 (Tue.) 12:00 pm, 2021.

# Section 4.2 Procedure

# 4.2.1 Applicants

# 4.2.1.1 Application registration

(1) Applicants are required to submit an application form via the Internet within the period indicated in 4.1.1 for registration of their application. The method of submitting the application form will be announced on HiGA's website (https://higa-s.jp/en/senior-high/application-process/) on June 1 (Tue.), 2021.

To register an application, the applicant's email address and the email address of the applicant's school are required. In principle, all contact from HiGA to the applicant and the principal of the applicant's school will be sent by email, so please make sure that you can receive email from the following email address.

(2) Applicants are required to pay an admission fee of 2,200 yen. The method of payment will be shown on HiGA's website in addition to 4.2.1.1. Please note that if HiGA is unable to confirm the payment of the admission fee within the period specified in 4.1.1 and/or 4.1.2, it is possible that the applicant may not be able to take the entrance examination.

In principle, HiGA will send information about the application folders to the applicant and the applicant's school within two weeks of receiving the application form.

# 4.2.1.2 Submission of application documents

□ Applicants

Applicants are required to fill out the following documents ① and ② and submit them to the principal of HiGA within the period specified in 4.1.2.

The documents ① and ② and their attachments must be submitted in PDF format in a digital folder designated by HiGA for each applicant. Submission by mail or by hand in person will not be accepted.

Heads of junior high schools are required to fill out and sign the following documents 3 and 4 and submit them to the principal of HiGA within the period specified in 4.1.2.

The documents ③ and ④ and their respective attachments must be submitted in PDF format in a digital folder designated by HiGA for each applicant. Submission by mail or by hand will not be accepted.

# Section 4.3 Others

- Applicants should receive an email from HiGA concerning the applicant and applicant's school folders within the first two weeks of submitting the application form or by September 2 (Thu.). Please contact HiGA with your name and date of birth (see p.13 for contact details), if you have not received any reply from HiGA.
- In principle, changes to the information provided in the registration of application are not permitted. In the unlikely event that there is a change in the email address used to contact you, please contact us immediately (see p.13 for contact details), indicating your name and date of birth, and inform us of the change.
- If any of the information on the application documents is found to be untrue, fraudulent or false, it is possible that the applicant's eligibility and admission will be withdrawn.
- Once the application documents and the admission fee have been received, they will not be returned under any circumstances.
- In principle, application documents should be prepared using computer software (e.g. Microsoft Word). The font size should be at least 10 points.
- All application documents must be prepared in English. However, ③ academic transcripts and ④ certificates of English language proficiency will be accepted in Japanese. Application documents (including attachments) written in a language other than English or Japanese, must be translated into English. Original documents must be verified and certified by the school corporation or

public institution from which you graduated. The document certifying the original and translated copies must be submitted with the application documents.

- All digital files submitted to the folder should be A4 size PDF format; files in other formats will not be accepted. If some part of the contents is unclear, it is possible that the applicant will be instructed to replace the files.
- Please make sure that you make one file for each of the application documents. The name of the file should be written in English as "Name of the application document\_Name of the applicant".

For example, if *Alfred Nobel* is submitting an *Essay describing the student*'s *motive for choosing HiGA*: "Essay\_Alfred Nobel".

 You may submit, replace, or revise your application documents as many times as you want during the period specified in 4.1.2. However, if there are several identical application documents submitted in a folder after the period outlined in 4.1.2, the school will decide which one will be accepted and the other identical files will be discarded.

#### **Chapter 5 Selection**

#### Section 5.1 First stage

#### 5.1.1 Document screening

All applicants will be screened on the basis of their application documents.

#### 5.1.2 Determination and announcement of the successful applicants

The principal of HiGA will make a decision based on a comprehensive evaluation of the application documents. The principal will notify successful applicants of the first stage after 11:00 a.m. on September 30 (Thu), 2021, by email using HiGA's email address. Please note that HiGA will not respond to individual inquiries.

#### 5.1.3 Withdraw from the second stage of selection

Applicants who have passed the first stage and wish to withdraw from the second stage must download the "Withdrawal Form for the Second Stage" from HiGA's website. This form will need to be filled in and submitted in PDF format to the applicant's folder by 4:00pm, on October 7 (Thu), 2021. Submission by mail or by hand will not be accepted.

If you do not submit the "Withdrawal Form for the Second Stage" by the deadline, we will assume that you intend to apply for the second stage.

# 5.1.4 Advancement

In the event that a vacancy arises due to withdrawals after the first stage has been announced, the principal may promote another candidate to fill the vacancy. In this case, the relevant candidate will be contacted by email to confirm their intention to apply for the second stage. Applicants who intend to apply for the second stage must immediately complete the prescribed procedures as instructed by HiGA.

#### Section 5.2 Second stage

Applicants who have passed the first stage will be invited to apply as follows.

#### 5.2.1 Interview

A personal interview will be conducted online, based on the application documents.

#### 5.2.2 Oral examination

An oral examination will be conducted online, based on a Mathematics and science reports (4.2.1.2 ④).

5.2.1 and 5.2.2 are carried out using Zoom Cloud Meetings (Zoom) provided by Zoom Video Communications Inc. The following preparations must be made prior to the date of the second stage.

- Please prepare a quiet environment (room) at your home or school etc.
- Please prepare a computer and headphones that can be used for video calls. You may choose to use a smartphone or tablet PC, but we recommend that you use a computer connected to a wired LAN with a stable internet connection.
- It is recommended to conduct a Zoom test meeting to check the microphone, speaker and video settings before the meeting. (Test meeting website: <u>http://zoom.us/test</u>)
- The Zoom account display name will be your examinee's number, so please check how to set your account name.
- Before carrying out 5.2.1 and 5.2.2, you will be asked to present your passport (Japanese citizens will be asked to present their My Number Card (your photo must be included), if they don't have a passport), to prove that you are the person taking the exam. If you don't have a passport or My Number Card in the interview, we will ask you to present it after you receive the successful announcement. Then, we will confirm the name, photograph and date of birth are consistent using the recording of the interview.

# 5.2.3 Date of the second stage of the selection

October 24 (Sun.) or October 25 (Mon.), 2021

# 5.2.4 Timetable of the examinations

The date and time for carrying out points 5.2.1 and 5.2.2 will be indicated later.

# 5.2.5 Venue of the examinations

The examinations will be held online using Zoom. (There is no need to come to HiGA.)

# 5.2.6 Notes of the second stage of the selection

- No one other than the candidate himself/herself is allowed to be in the room where the candidate takes the second stage of selection. No other person is allowed to communicate with the candidate during the interview. In order to prevent fraud, the use of virtual backgrounds is not permitted.
- In principle, applicants are not allowed to leave the room during 5.2.1 and 5.2.2. If an applicant leaves the room without permission, it is possible he/she may not be allowed to re-enter the room. It is also possible HiGA may postpone or cancel 5.2.1 and/or 5.2.2 for the applicant, if HiGA judges that it is difficult to continue with 5.2.1 and 5.2.2 because of connection issues, or the student is unable to reenter the zoom meeting. In this case, HiGA will decide whether or not 5.2.1 and 5.2.2 will be rescheduled and will contact the applicant through his/her email. Please note that problems with the connection environment will not affect the selection in the second stage.
- No other equipment other than the computer connected to HiGA using Zoom is allowed to be used while 5.2.1 and 5.2.2 are being conducted. It is also not permitted to operate the computer unless instructed to do so by the interviewers.
- Candidates will not be allowed to record (video, audio, etc.) or make available to the outside world any of the information in 5.2.1 and 5.2.2. In order to ensure the fairness of the selection process, HiGA will record both 5.2.1 and 5.2.2. The recorded data will be strictly controlled by HiGA and will be used only for the purposes of HiGA's admissions procedures.
- The acceptance and admission of the applicant will be withdrawn if it becomes known that any of these points have been breached, and HiGA considers this to be fraudulent.
- In spite of the points above, all instructions from HiGA must be followed.

#### Chapter 6 Determination of successful applicants

The principal of HiGA will make a decision on successful applicants after taking the results of 5.2.1 and 5.2.2 into account.

# Chapter 7 Announcement of successful applicants

# Section 7.1 Schedule

The principal of HiGA will notify successful candidates through their email after 11:00 a.m. on November 2 (Tue.), 2021. The school will not respond to individual inquiries about the selection.

#### Section 7.2 Procedure after announcement

- Successful applicants are requested to download the Application of Enrollment or Withdrawal Form from HiGA's website, fill in the necessary information on the Application of Enrollment for those who are committed to enrolling at HiGA, or the Withdrawal Form for those who want to withdraw from HiGA admission. The form then needs to be submitted to the shared folder by November 9 (Tue.) 12:00 PM, 2021. Submissions by mail or by hand will not be accepted. Applicants who have submitted an Application of Enrollment cannot withdraw from enrollment at HiGA. Candidates will not be enrolled if the Application of Enrollment is not submitted by the deadline.
- The principal reserves the right to promote unsuccessful candidates from the second stage In the event that a vacancy arises due to withdrawals. However, the number of promoted candidates cannot exceed the number of withdrawals. In this case, the promoted candidate will be contacted by email to confirm their intention to enroll. Candidates who intend to enroll are required to follow the procedures as instructed by HiGA as soon as possible.
- Those who have submitted the *Application of Enrollment* are required to attend the orientation sessions for prospective students to be held on Saturday, November 27 (Sat.), 2021 and January 22 (Sat.), 2022. These sessions will be held online via Zoom. Information on how to participate will be sent later to those eligible to attend through email.

# Chapter 8 HiGA's entrance period

If the applicant meets the eligibility by the end of March 2022, entry will be in April. Thereafter, if the student meets the eligibility by the end of August 2022, the student will be admitted in September. In both cases, the expected graduation date is March 2025. In the event that a successful applicant is unable to enter Japan due to a COVID-19 situation, HiGA and the successful applicant will discuss the possibility of admission.

# **Chapter 9 Others**

- The principal reserves the right to cancel an application if it is found to be false (e.g., Academic transcript), even after the application has been accepted.
- The forms in 4.2.1.2 can be downloaded from the website of the Hiroshima Prefectural Board of Education or from HiGA's website.
- All dates and times shown in this document are given in Japanese Standard Time (JST).
- If you are unable to use the internet or have any other questions or difficulties in registering your application, please contact us (see p.13 for contact details) with your name and date of birth.
- Personal information (name, address, date of birth, and all other information) obtained through the admissions process is used for the purposes of admissions, notification of acceptance, admission procedures, and the enrollment.
- Depending on the situation of COVID-19, amendments to the guideline could be made. In such a case, we will post a notice on the HiGA's website.
