

## 高等学校等就学支援金・高校生等臨時支援金（給付） High School Tuition Support Fund (Grant)

毎月の授業料や年間の受講料を支援する制度です。（４月に申請受付・全員手続）

A system to provide financial aid to cover monthly tuition or yearly lecture fees (Applications accepted in April / Required for all students)

### 1 手続

高校等へ入学した生徒は、原則全員が申請手続を行う必要があります。

令和５年度から原則、オンラインでの申請となっています。

オンライン申請に必要なＩＤ、パスワードや手続方法は入学決定後に各家庭に郵送します。

### 1 Procedure

As a general rule, all students who have enrolled in a high school are required to go through the application procedure.

From 2023, applications will, as a general rule, be accepted online.

The ID and password necessary for the online application, as well as information on the procedure will be sent by postal mail to each household after the enrollment decision is finalized.

### 2 対象者

次のいずれにも該当する者

- ・ 広島県内の公立高校等に在学する生徒

ただし、次の方は対象となりません。

- ① 高等学校等を既に卒業したことのある生徒や３年（定時制課程・通信制課程は４年）を超えて在籍している生徒（以前に高等学校等に在籍した期間がある場合はその期間も含める。）
- ② 科目履修生や聴講生

### 2 Eligibility

Those who fall under both of the following conditions:

- ・ A student currently enrolled in a public high school in Hiroshima Prefecture

However, those listed below are not eligible.

- ① A student who has already graduated from a high school or has exceeded three years of enrollment (four years for part-time and correspondence courses) (If a student was enrolled in a high school in the past, such period must be counted in computing the total length of enrollment.)
- ② A non-degree student or auditing student

### 3 支給額

授業料（例：全日制で月額9,900円・年額118,800円）又は受講料に相当する額が国から県・市へ支給され、対象者の授業料等に充当されます。

これにより、生徒・保護者等の授業料等の負担が実質0円となります。

### 3 Amount of Payment

Funds in the amount equivalent to tuition (e.g., 9,900 yen per month, 118,800 yen per year for full-time high schools) or lecture fees are paid by the national government to the prefecture/city and then appropriated for the tuition, etc. of an eligible student.

Through this system, eligible students and their parents/guardians will bear virtually zero tuition, etc.

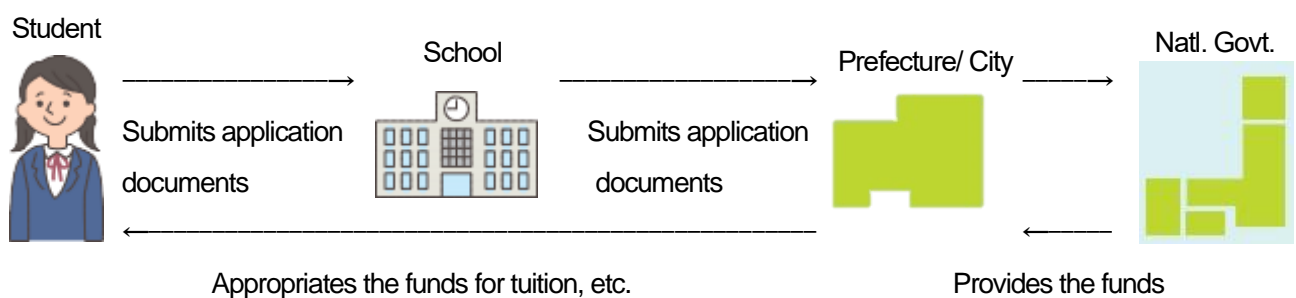
★ 期限までに申請されなかった場合は、就学支援金等が受けられないため、気を付けてください。



(例) 全日制課程：年額118,800円の就学支援金等を授業料に充てます

★ The same system applies to national and private high schools. For details, contact your school directly.

★ Please note that failing to meet the application deadline will disqualify you from receiving funds from the Tuition Support Fund.



(Example) Full-time course: Funds in the annual amount of 118,800 yen are appropriated from the Tuition Support Fund for tuition fees.

〔手続にはマイナンバーの提出が必要です！〕

就学支援金等の制度の手続において、保護者等全員のマイナンバー（個人番号）を提出していただく必要があります。

※ 税の申告を行っていない場合、申請いただいても所得確認ができませんので、事前に市区町村において、個人住民税の申告手続をお願いします。

[The application procedure requires submission of your Individual Number (commonly known as “My Number”)]

The procedure for the Tuition Support Fund system requires submission of the Individual Number of all parents/guardians of the students.

※ To apply for the Fund, a tax return must have been filed, without which household income cannot be verified.  
Please ensure that prior to the application you file your residential tax return in your city.
