Refresher courses for good drivers are given after the procedure finished. - Residents of Hiroshima Prefecture (except Naka-ku, Higashi-ku, Nishi-ku, Minami-ku, Asaminami-ku, Asakita-ku, Saeki-ku Hiroshima-city, Hatsukajichi-city, Fukuyama-city, Onomichi-city and Aki-gun Fuchu-cho) may renew or reissue license at their respective district police stations. For further information, please ask at each police stations. - Change of information on license can be done at respective district police stations from Monday to Friday (except national holidays and from December 29 to January 3). Conditions for Application	- Residents of Hiroshima Prefecture (including those whose address written on the license is in Hiroshima prefecture) ※ Reservations have to be made beforehand for examinations which include Driving Technique Test. Places to get designation ~ License Center, Miyoshi Examination Hall and the nearest Police stations	- Those who could not renew their licenses and are within 6 months from expiration date. ※ Those who could not renew their licenses within 6 months from expiration date due to unavoidable circumstances such as illness, overseas travel, etc. must apply within one month from the date that these circumstances are over. ○ At Miyoshi Examination Hall, you need to take a refresher course at the time of renewal of licenses before application. At License Center you can take a refresher course at the time of renewal of licenses on the day of application but those who take a refresher course for ordinary drivers, course for the first time renewal and course for violators must apply between 8:30 and 9:00. ○ Those who are more than 70-year-old must take a course for senior drivers before application.
